**SCIENTIFIC WORKS FOR THE CONFERENCE**  
**ENERGY: INFRASTRUCTURE AND LOGISTICS**  
**MACK INTEGRIDADE**

**THE MACK INTEGRITY - MACKENZIE CENTER FOR PUBLIC POLICY AND INTEGRITY**, a multidisciplinary academic-administrative center for research in science and technological innovations of the Instituto Presbiteriano Mackenzie, which aims to provide advanced studies on Public Policies and Integrity Policies, through its **Center of Energy, Sustainability and Regulation**, hereby invites the academic Community to submit scientific works in the extended abstract format for presentation at the **ENERGY CONFERENCE: INFRASTRUCTURE AND LOGISTICS**, to be held on May 16th and 17th, 2024, in the Mackgraphe auditorium, Campus Mackenzie – Higienópolis, in São Paulo, Brazil. The selected abstracts must be developed into scientific articles to compose a collective work, in accordance with the rules of this notice.

**1. SCOPE:**

**1.1.** The academic activity consists of presenting extended abstracts, which will be evaluated and selected to be developed into chapters that will be part of a collective work. The work will feature the participation of teachers, professionals in the field and academics from undergraduate and postgraduate courses across the entire academic community. Issues related to the topic of Energy and Sustainability will be explored. The works will be presented in different thematic panels during two days of Conference.

**1.2.** The thematic lines explored at this event will be:

- Economic Law and the Regulation of Energy Transition
- Infrastructure and Logistics: Public policies and Education
- Sanitation, Biomethane and Energy Use of Waste
- Energy transition and Public Policies in Artificial Intelligence
- Agro and Biofuels: Governance and legal environment for global protagonism

**1.3.** Presentations of extended abstracts that meet the requirements of this call for Papers will be selected by the Scientific Committee. At the end of the

Conference, there will be awards for the three best works as evaluated by the Scientific Committee.

**1.4.** The event participant will be able to attend the exhibitions, in which case they will receive a certificate with the number of hours attended. If the participant presents scientific work, a certificate of presentation will be received.

## **2. SELECTION PROCEDURE**

**2.1** The presentation of abstracts will take place on May 16th and 17th, 2024 and the judging and respective awards will take place during the closing ceremony.

**2.2** The authors will initially forward an expanded abstract to [mack.integridade@gmail.com](mailto:mack.integridade@gmail.com) until April 12, 2024. The abstract will be evaluated by Scientific Committee of this event and all candidates will be notified of the result. Only authors whose abstracts are approved will be invited to present during the event. If the summary requires any adjustments, but is, in the general, appropriate, the Scientific Committee may suggest recommendations that, if followed and carried out, may imply approval of the work.

**2.3** Abstracts developed by academics, teachers, researchers, and professionals who work or have worked on the topic lines can be admitted. Scientific works with a maximum of 03 authors will be admitted, as long as at least one of the authors hold a PhD degree.

**2.4** Submitted works must be unpublished and necessarily fit into in one of the thematic axes below:

- Economic Law and the Regulation of Energy Transition – Economic Environmental Law; new economic and legal frontiers; structuring and modeling regulatory framework: experimental regulation, self-regulation, regulatory sandbox; policies promoting production and investment in new sources (clean hydrogen, wind offshore etc.); climate and energy litigation; regulatory legal solutions International.

- Infrastructure and Logistics: Public policies and Education – neoindustrialization; governance of infrastructure and logistics of the Brazilian energy matrix; infrastructure, sustainability and environmental licensing; modernization the transport sector and new energy modes; R&D funds; bibliographical survey (state of the art) of international opportunities in scientific research and technological transfer.

- Sanitation, Biomethane and Energy Utilization Technologies – fuels waste derivatives; energy and climate justice and urban sanitation; control emissions in energy production and technological controversies; technologies of carbon capture, storage and use; available funds and investments for the sector.

- Energy transition and Public Policies in Artificial Intelligence – demands of the Brazilian market and regulatory strategy; legislative process; technological innovations for energy efficiency; R&D governance.

- Agriculture and Biofuels: Governance and global protagonism – economic pillars; decarbonization of production chains; Production sustainability and Nature Based Solutions; Carbon Markets; synergies between agribusiness and transition energy; evolution of sectoral governance and technological innovation; market opportunities International.

**2.5** When submitting the work, the author(s) will be automatically authorizing the publication of the work in the format of a scientific article in print, on the internet, in a book or in any other media.

**2.6** The criteria considered by the Scientific Committee will be: (i) thematic suitability to the Conference; (ii) relevance of the theme and originality; (iii) methodology; (iv) structuring and (v) scientific writing.

### **3. DEADLINES AND EXTENDED ABSTRACTS SENDING**

**3.1** Communication will be made via [www.mackenzie.br/mackintegridade/energia](http://www.mackenzie.br/mackintegridade/energia) and scientific work must be sent via the following email address [mack.integridade@gmail.com](mailto:mack.integridade@gmail.com) with the title 2024 Energy Conference.

**3.2** The submission and approval of abstracts will follow four stages according to the schedule of this call for papers: (i) sending abstracts; (ii) evaluation of abstracts; (iii) communication of selected abstracts; and (iv) presentation of abstracts during the event. The authors of the abstracts must attend (in person or virtually) on May 16th and 17th 2024 at the time informed for participation in the Conference and present to the Scientific Committee and guests.

**3.3** Authors of approved extended abstracts must meet the deadline submission of the respective scientific article so that it can be included in a collective work without burden for the authors, in accordance with the criteria of this notice.

**3.4** The authors of selected abstracts must send confirmation of their presence to the event email until May 10, 2024, to present the abstract and inform the type of presentation (in-person or virtual).

**3.5** After presenting the selected expanded abstracts, authors must submit the work in the form of a scientific article according to the specifications of this notice

and these works will be evaluated by the Scientific Committee according to the blind peer review system.

**3.6** All approved articles will be published in a collective work, in accordance with schedule below, subject to the signing of the originality term and authorization of publication:

**3.7** Authors whose works are approved will receive a copy of the collective work.

#### **4. GUIDELINES FOR FORMATTING SCIENTIFIC WORKS**

**4.1** Abstracts submitted must contain 3 to 5 pages and observe the following elements: Title, Author/s, Introduction, Objectives, Methodology, Results and Conclusion. The Scientific articles, in turn, must contain 10 to 15 pages and must contain the following elements: title, identification of authors and affiliation, summary/abstract (Portuguese and English), sub-items (development), conclusions and references.

**4.2** The spacing between lines must be 1.5, “Justify text” Alignment and Times New Roman font, body 12.

**4.3** The paragraph must be indented 1.5 cm from the left alignment and 0 cm, before and after.

**4.4** Titles and subtitles must be typed in capital letters, in bold, with font size 12 and in Times New Roman, single spacing.

**4.5** The following page structure must be observed: Top margin: 3 cm, Bottom margin: 3 cm, Right margin: 2 cm, Left margin: 2 cm.

**4.6** Citations of up to 3 lines must be in the body of the text, between quotation marks, followed by reference in the author-date system (font size 10).

**4.7** Long citations, with more than 3 lines, must be indented according to the ABNT standard (indentation) 4.0 cm from the left margin, Times New Roman font – size 10 – Spacing simple).

**4.8** References must be included at the end of the text, in alphabetical order by surname of the author, in single space, aligned only to the left, separated by a line of 1.0 space.

**4.9** Other ABNT standards must be observed, also respecting the model author-date (NBR 10520).

## **5. PRESENTATIONS:**

**5.1** Approved works must be presented orally and preferably in person, at the time to be indicated by the Organizing Committee.

**5.2** The presentation time will be 10 minutes per work, regardless of the number of authors.

**5.3** It is possible for only one of the authors to make the presentation.

**5.4** In-person presentations will take place in the Mackgrape Auditorium, on Campus Higienopolis of Mackenzie Presbyterian University, Sao Paulo, according to item 3 of this notice.

**5.5** If it is impossible for at least one of the authors (in the case of co-authorship) to be present for the presentation, this information must be communicated to the organization via the email in item 3.1., so that they can be assigned a link for synchronous virtual access to the event.

**5.6** The oral presentation of approved works will also be evaluated for the purposes of awards.

## **6. AWARDS**

6.1 Participation certificates will be issued for all approved work.

6.2 The authors of the 3 best evaluated works will receive a certificate with Special mention.

6.3 The 3 best evaluated works will be published on the MACK INTEGRIDADE website which will include visual art about the article, photo and academic and professional mini biography of the author(s).

## **7. SCIENTIFIC COMMITTEE:**

**7.1** The general organization of the Conference will include a Scientific Committee and an Organizing Committee, responsible respectively for analyzing the work submitted and for the communication and organization of the Conference.

**7.2** The Scientific Committee is made up of professionals who hold a minimum degree of PhD (or equivalent) and experience in the areas and themes set out in this notice.

**7.3** The Scientific Committee will be responsible for analyzing, accepting, or rejecting the proposals submitted via email, based on the criteria for compliance with the rules of this notice, in addition to the scientific relevance, clarity and objectivity necessary for an academic work.

## **8. GENERAL PROVISIONS**

Situations that are not specified by this regulation will be resolved by the Organizing committee.
