

Aiming at the integral development of its students, Mackenzie prepares them from preschool, in Basic Education, passing through undergraduate education with courses in all the areas of knowledge, up to postgraduate education, in levels of specialization, master's and doctorate, besides the courses in Distance Higher Education (EaD).

Since 2017, as part of its expansion process and in line with its vocation, Mackenzie has expanded its activities in the area of health, associating with institutions that are a reference in its areas of business. The Institution now has two hospitals, a college of medicine and a technical nursing school.


STRUCTURE

In its ten* face to face campuses Mackenzie houses 846 classrooms, 319 laboratories and 17 auditoriums, comprised of 912,986 m² of land and 209,052 m² of built area.

The two hospitals, Curitiba and Dourados, have 544 active beds in 34,931 m² of built area.






Scholarships and discounts granted¹





Mackenzie Institutional Identity represents the set of primary elements that characterize its structure, own will, and basic beliefs – that transcend circumstances and are not circumscribed by the internal or external environment, nor by its current capabilities. Mackenzie Institutional Identity is composed of Confessionality, Mission, Vision, Principles and Values. These are expressed as follows:



CONFESSIONALITY

We believe that God is the reference of all reality and His Kingdom is manifested in all areas. This reality must be understood by the Creation-Fall-Redemption structure revealed in the Holy Bible.



MISSION

To educate human beings, created in the image of God, for the full exercise of citizenship, in a set of Reformed Christian faith.



VISION

To be recognized by society as a Confessional Presbyterian and philanthropic institution, dedicated to the divine and human sciences, committed to social and environmental responsibility, in continuous search for academic and management excellence.

Principles and values

- o In personal conduct: dignity, character, integrity and displaying a Mackenzie "school spirit".
- O In professional activity: ethics, competence, creativity, discipline, dedication and willingness to volunteer work.
- **o In interpersonal relationships:** loyalty, mutual respect, understanding, honesty and humbleness.
- **o In decision-making process:** seeking consensus, justice, truth and equal opportunity for all.

- o And in all circumstances: act with love, which is the bond of perfection.



CONFESSIONALITY

Christian Confessionality takes the Scriptures as lenses to bring focus to all knowledge that pertains to human knowledge. With the threefold perspective of creation, fall and redemption, Confessionality avoids the dichotomies of secular thought and promotes a worldview that is transcendent and applied transversally (touches on the whole range of areas of knowledge), permeating (penetrates to the root of the things) and transparent (it is forthright and also it is not opaque – its perspective enriches the vision of its objects, improves, contrasts and expands details).


Hence, our Confessionality allows us to offer certain "gifts" to those whom Mackenzie whishes to serve in the name of Christ. Knowledge of the redemptive grace of God in Christ, of course, is the greatest gift offered in the proclamation of the gospel and the lordship of Christ. But this proclamation goes on and flows to broaden aspects, as a testimony that the lordship of Christ extends over every aspect of life, as a challenge to unbelief and hopelessness, and as the possibility of a redemptive vision of human knowledge and positive action in this world that lies in darkness but longs ardently for redemption (Romans 8).




CHANCELLOR'S OFFICE

With this commitment, it transmits to Mackenzie community, words of guidance and encouragement at special moments or times of crisis, challenging, through the preaching of the gospel, the engagement in the Christian worldview. Some activities are developed primarily by a group of students, with the support and partnership of the Chaplaincy.





HIGHER EDUCATION

MACKENZIE PRESBYTERIAN UNIVERSITY (UPM)

During its 66 years of existence, Mackenzie Presbyterian University, with a Confessional identity and recognized as a community Higher Education Institution (HEI). Its activities touch the most diverse areas of human knowledge.

Presence:

- 3 campuses: Higienópolis (SP), Alphaville (Barueri-SP) and Campinas (SP).
- 40 poles of distance education (EaD).

Courses offered:

- 36 face to face undergraduate courses.
- 14 stricto sensu postgraduate programs: 9 doctoral courses and 14 master's degree courses.
- 60 *lato sensu* specialization courses and portfolio of extension activities.
- Distance education: 12 undergraduate courses (6 licentiate degree courses and 6 technology courses) and 30 postgraduate courses.



MACKENZIE PRESBYTERIAN SCHOOLS

The Basic Education comprises the Units of Mackenzie Presbyterian Schools São Paulo (SP), Tamboré (Barueri-SP), Brasília (DF) and Palmas (TO), with 8,531 students in 2018, plus Mackenzie Presbyterian School for Youth and Adult Edu-

cation – AEJAMack (SP), the Christian Institute School – Castro (PR) and School Vital Brasil – Dourados (MS). All the units bring together about **9,300 students, 600** teachers and **390 direct assistants**.

MACKENZIE TEACHING SYSTEMS

Mackenzie Teaching Systems include the Mackenzie Teaching System (SME) of explicit Confessionality, and Educational Mackenzie (ME) of implicit Confessionality. In the year, 343 partner schools and 57,668 students have used the materials, an increase of 28% and 16.8%, respectively, representing the reach of the Mackenzie philosophy in the country. MACKENZIE SOLUTIONS

Mackenzie Solutions is a business unit that works with special and consulting projects, research and development, recruiting students for corporate education in Company and Multicompany, prospecting of Distance Education poles, technical and educational agreements, Editora Mackenzie and the management and leasing of spaces of the Institution.

The revenues of Mackenzie Solutions reached R\$123.2 million in 2018, with emphasis on the area of Agreements.

HEALTH

At the end of 2017 Mackenzie became member of the association that controls the Evangelical Hospital of Dourados (MS), and at the end of 2018 it acquired, in a public auction, the University Hospital and the Evangelical College of Medicine, both in Curitiba (PR), thus consolidating the entrance of the Institution into the health area.





Evangelical Hospital - Dourados

- 57.7 thousand care and surgeries in 2018. Occupancy rate of 55%.

Mackenzie Evangelical University Hospital – Curitiba (HUEM)

- Reference hospital in the area of burned people with 447 beds, of which 386 are destined to SUS (national public health system).
- 1.1 million care and procedures, in addition to 18,300 surgeries in 2018.

Mackenzie Evangelical College of Paraná – Curitiba (FEMPAR)

- Undergraduate course in Medicine, *stricto sensu* postgraduate courses (master's and doctorate) in Principles of Surgery and other 29 *lato sensu* courses.
- 18 classrooms and 17 laboratories in 7.800 m² of built area.
- Quality of teaching score 4 for the indicators of Institutional Score (CI), General Course Index (IGC) and Course Score (CC); score 3 for the Preliminary Course Score (CPC) indicator (scores given on a scale from 1 to 5).

Strategic Planning


The Board of Directors of Mackenzie Presbyterian Institute (IPM) approved in June 2018 the tenth edition of its Strategic Planning, which covers the period 2019-2028.

- 1. It does not consider the units of Curitiba, Castro and Dourados. At IPM and Maintained Entities, 50% of the employees were composed of women and 50% of men. In the year, employee turnover was 8.7%
- 2. It does not consider 81 employees in absence period.
- 3. The medical staff is composed of professionals that provide their services to the hospitals. They are not tied to payroll of health institutions.

Organizational Structure and Atmosphere*

Mackenzie organizational structuring project begun in 2016 and has advanced with the purpose of mapping and adapting the functional organization chart of the Institution as well as the duties and requirements of all positions. While the organizational atmosphere, evaluated in the year, indicated a 77% approval rate.

Training and development*

Investment of R\$1.857 million in programs aimed at improving the workforce, which benefited 11,013 participants and

resulted in an average of 6.05 hours per year. In addition, during the year several actions were carried out aiming at the health and well-being of employees.

Benefits*

With a focus on social responsibility and philanthropy, and to provide quality of life for its employees, Mackenzie maintains the following set of benefits: education financial aid, day care allowance and agreement, private pension, medical and dental care, food basket and food stamp, life insurance, pharmacy agreement, meal voucher and meal card, payroll deductible loan.



part, in the granting of scholarships and consequent offer of opportunities to those who could not, by their own conditions, enjoy the benefits of study at Mackenzie. 
EVOLUTION IN THE NUMBER OF SCHOLARSHIPS GRANTED

Social projects

Mackenzie develops socio-educational projects in two modalities:

Own projects appropriated for philanthropic governmental incentives, according to current legislation, in which the amounts are destined to assistance and support actions to scholarship students.

Projects not eligible for tax incentives are maintained by the Institution because they meet its statutory and Confessional purposes.
 They are carried out with own resources and in partnership.

The investment in socio-educational projects benefited 148.5 thousand direct beneficiaries, with approximately R\$1.89 million invested, of which R\$453 thousand are contemplated by the law that governs philanthropy.







Mackenzie Volunteer

The project aims at encouraging volunteering, community participation and social entrepreneurship by promoting educational actions involving students and the community in general in projects that focus on the 17 Sustainable Development Goals established by the United Nations Organization (UNO). Another relevant aspect is its result in terms of participation of volunteers and supporters through service and donation of materials.

Solidary Mackenzie

Implemented in 2016, it counts on the partnership of main supplying companies of Mackenzie, aiming at the return to the labor market of students, former students and persons in charge. With 157 participating companies, it has already helped 43 candidates to return to their professions.

ENVIRONMENTAL RESPONSIBILITY

Environmental sustainability permeates several action fronts at Mackenzie, from contents and field lessons in Basic Education, and research and extension projects carried out by UPM to care for efficient water and energy management – fundamental resources for the maintenance of activities on the campuses.





Electricity	Reduction of consumption by 18% in relation to the previous year. The Institution has been working on the transition from low efficiency equipment to more modern and high performance technologies.	
Water	Reduction of consumption by 11% in relation to the previous year. In the management of water resources, Mackenzie has adopted initiatives to rationalize consumption, such as the installation of flow reducers and the monitoring of leaks.	
Materials and Solid Waste	The Higienópolis <i>campus</i> presents the largest volume of waste generation among the units of Mackenzie. Outstanding is the <i>Reviravolta</i> Project (collecting 97 tons of recyclables) and the <i>Recicle Mais-Pague Menos</i> Project (48.6 tons of recyclables). The units of Barueri, Campinas and Brasília have also advanced in the collection of solid waste.


Mackenzie maintains firm and strategic economic and financial management, backed by annual budget planning aimed at the sustainability of operations.

SEGREGATION OF GROSS REVENUE (%)




DEFAULT - EVOLUTION [%]



Mackenzie policy is to **reinvest all of the gains accrued** as a result of its activities. The volume of investments in 2018 was 383% higher than in 2017, equivalent to R\$240.8 million, or 253% of the surplus, due to investments made in the year with the acquisition of FEMPAR and HUEM in Curitiba.



INVESTMENTS [%]




