United States. Wisconsin University Law School

Period: 10/21/2019 to 10/27/2019. Researcher: Fábio Ramazzini Bechara

The mission was held at Wisconsin University Law School at the University of Wisconsin, Madison, for 7 days, between October 21 and 27, 2019. Prior to the arrival of researcher Fábio Bechara in American soil, a meeting was held with Assistant Dean for Graduate Programs at the University of Wisconsin Law School – UW Law School, Jason Smith, to discuss dual degree programs; student, teacher and researcher mobility; the promotion of network research and publications.

Meetings were held at the University of Wisconsin with Sumudu Atapattu, Director of Research Centers and Senior Lecturer at UW Law School, and subsequently with Alberto Vargas, Assistant Director of the Latin America, Caribbean and Iberian Studies Program for the purpose of promoting network research; student, teacher and researcher mobility. Professor Fabio Bechara also met with Maj Fisher, Director of Foreign Affairs at the University of Wisconsin - Madison International Division, to formalize the Memorandum of Understanding - MOU; besides searching for network research; student, faculty, and researcher mobility, and met with Robert Ling III - Senior Article Editor of Wisconsin International Law Journal to promote networked publications and research; as well as to organize a symposium for 2020 or 2021, taking the theme of the PrInt project "Social Inclusion, Public Policy and Governance to reduce inequalities" as content of papers. Professor Bechara also reunited with Tatiana Shirasaki, Assistant Director of Admissions at UW Law School for the purpose of promoting network research; student, teacher and researcher mobility. The researcher also had contact with Olivia Radics, Editor-in-Chief of the Wisconsin Law Review, for the purpose of promoting a publication and networking research, and with John Ohnesorge – Professor and Director of the Asian Legal Studies Center - UW Law School to promote network research and researcher mobility.

Professor Bechara attended the conference "Forensic Science" and "Wisconsin Law Review Symposium" (October 24 and 25, 2019). He was admitted as a visiting professor and gave two lectures during his permanence entitled "Anticorruption policies in Brazil after Lava Jet Case: lessons and challenges" and "Illegal Immigration and criminal cases". A publication in partnership with a researcher at UW Law School entitled "Comparative analysis of Brazilian and American migration policy, was initiated, to be published in the second semester of 2020. Research activities were also carried out: bibliographic survey to enrich scientific articles.
